7 Early questions and early motions as appearing on the Business Paper

7.1 The Reverend Brett Gibson, Parish of Canning

What initiatives did the parishes of the Diocese activate as part of the National Church's Hope25 project?

The Church's missionary vocation is a continuation of Christ's own mission to the world: "As the Father has sent me, so I send you" (John 20:21). In this spirit, the Anglican Church of Australia launched Hope25 — a national season of intentional witness and outreach, running from Easter Sunday to Pentecost Sunday in 2025. Each parish was encouraged to undertake at least one local initiative during this period, with the goal of seeing every Anglican church across cities, suburbs, towns, and rural areas participate in proclaiming the hope of Christ to their communities.

Although the formal period of Hope25 has concluded, many parishes are continuing the momentum it generated. Across the country, churches are maintaining their focus on local mission, offering welcome, worship, and practical expressions of God's love. The Church's commitment to mission remains ongoing and is not confined to a single season.

7.2 Mr Jack Lambert, Social Responsibilities Commission

What are our agencies, in particular St Bart's and Anglicare WA, doing to support those at risk of or are experiencing homelessness in our city?

St Bart's

Across all our services, St Bart's directly supported 1,200 people and received 2,425 enquiries for help, this was up 17% from last year.

St Bart's provides a range of supported accommodation options, including social housing, residential aged care, independent living and short stay services for individuals experiencing homelessness or housing insecurity. Many of our clients are impacted by unjust structures of society and live on very low incomes, facing complex challenges such as chronic physical and or histories of rough sleeping. For older members of the community who have experienced homelessness and now require aged care, we understand their history and through our compassionate service, we support them.

Through partnerships we provide care bags to rough sleepers while they are looking for a home and we connect them rough sleeper co-ordination groups to help them access accommodation and gain the support they need.

St Bart's responds to our consumers' needs to support their goals, walking alongside them on their journey and providing care through a nurtured trauma informed approach. We recognise each person as a unique individual with their own history, while focussing on supporting them to reclaim their journey. We provide pathways for our consumers to connect or reconnect with God through our chaplaincy support and how we reflect God's love, compassion and care in the way we work to deliver our mission.

St Bart's does not judge. We understand the many complexities of the persons past trauma and gently challenge them to reflect on the reasons behind violent behaviour, while never condoning it. We do not turn people away when they are at their most vulnerable. Instead, we seek to understand and support those who have experienced all forms of violence, helping them to reclaim their story.

Anglicare WA

Anglicare WA's work is grounded in the third and fourth Marks of Mission: responding to human need through loving service and transforming unjust structures of society to challenge violence and pursue peace and reconciliation. These principles shape our purpose - to drive positive outcomes with those in need and challenge barriers to thriving.

Anglicare WA believes that everyone deserves a safe and stable home. Housing profoundly affects every aspect of life - from health and relationships to security and hope for the future. That's why Anglicare WA offers a range of services to support people who are at risk of, or currently experiencing, homelessness.

Consistent with the Third Mark of Mission:

To respond to human need through loving service

We work with people experiencing homelessness, facing housing instability, or at risk of losing their homes. Whether navigating a crisis or trying to maintain a current tenancy, we are here to support them every step of the way. Our approach is compassionate, respectful, and focused on long-term stability.

Our services include Housing Support Services, which help people explore and secure stable housing options, including referrals to crisis accommodation and long-term solutions. We also offer Tenancy Support, assisting with maintaining tenancies in both public and private rentals through help with paperwork, budgeting, financial counselling, rent arrears, and communication with landlords to help retain their tenancy.

In addition, we provide Skill Building to develop essential life skills such as managing finances, maintaining a home, and accessing community resources. Our Specialist Programs, like Foyer Oxford, Street Connect, YES! Housing and Housing First Support offer targeted assistance for young people, families, and individuals with complex needs who are experiencing homelessness or imminent homelessness. When needed, we can connect people with Emergency Relief, including food, clothing, and financial aid.

Anglicare WA's housing and homelessness services supported 8621 people (317 people in adult housing and 545 people in youth housing) in the Perth metropolitan area, including Rockingham in 2024/25. Of this number, 635 were under 24 years of age.

Anglicare WA also partners with Vinnies and other agencies to deliver the WA Rent Relief Program, which in 2024/25 supported 1,506 households with an average payment of \$4,455 per household to cover rent arrears, secure rental payments for up to three months, and maintain tenancies with landlords, therefore avoiding eviction and reducing the risk of homelessness.

Consistent with the Fourth Mark of Mission:

To transform unjust structures of society, to challenge violence of every kind and pursue peace and reconciliation

In 2024/25, Anglicare WA advocated to overcome barriers to achieving safe, secure, and healthy homes. We shared policy solutions (outlined below) with Members of Parliament, election candidates, media, social media, community, and industry forums ahead of the 2025 State and Federal elections to address the causes of homelessness and continue to advocate for change. Anglicare WA is also represented on the Alliance Steering Committee of the Western Australian Alliance to End Homelessness and actively participates in the Advance to Zero campaign.

Short-term solutions:

Focus on keeping people in their current housing and preventing homelessness include raising the federal income support payment to \$82 per day, extending the WA Rent Relief Program until the rental market stabilises at a vacancy rate of 2.5% to 3.5%, and creating a WA Rental Affordability Scheme (to replace the national scheme) to keep around 3,700 people in affordable rentals.

Youth Housing: Foyer Oxford, Street Connect, Yes! Housing, and Youth Supported Housing and Crisis Accommodation (Rockingham and Spearwood).

¹ Adult Housing: Supported Tenancy Anglicare Rockingham, Family Housing, and Housing Support Workers in the Perth Metropolitan and Peel regions.

Additionally, increasing income eligibility and grace periods for public housing, scaling up prevention efforts in family violence, mental health, and substance abuse, and early intervention programs like financial counselling are key measures. Expanding crisis and supported accommodation options, such as Youth Foyers, further support this goal.

Medium-term solutions:

Focus on reform such as reforming the Residential Tenancies Act to include rent stabilisation, introducing minimum standards for all rentals, ending no-grounds evictions, and extending legal protection to boarders and lodgers.

Implementing a fair tax system to gradually decrease the Capital Gains Tax discount over the next ten years and using negative gearing to promote investment in social housing or restrict its application to a select number of properties within a portfolio.

Reforming the Commonwealth Rent Assistance that redirects the payment to increase working-age income support payments, or if the payment is retained, index to rental prices instead of inflation, and eligibility to access should be broadened.

Long-term solutions:

Include creating a vision for housing in Western Australia that sets a target of 6% of the total housing stock as social housing (currently 3.7%) and establishing a WA Housing Future Fund by setting aside \$1 billion of the state's surplus in perpetuity using annual returns to fund new builds.

7.3 The Reverend Dr Noah Mbano, Parish of Serpentine-Jarrahdale

How many people engaged with Wollaston Theological College this past year and what are some of the activities and events which brought people to connect with the College?

The College undertook a count of people attending events and meetings at the College during an eight month period from November 2024 to June 2025. The count *did not* include student attendance at ordinary midweek classes and worship in the Chapel, casual visitors to the library, or casual visits by AngliSchools staff.

During that period just in excess of 2,500 people participated in a wide-sweep of educational, development, training events, engagement activities and meetings of the Diocese at Wollaston Theological College.

Some of the meetings and functions were events held by the college itself. For example, 80 people attended the Commissioning Service for the new Principal in November, while 50 people attended a formation luncheon for the end of the academic year. In February, 80 people attended the Summer Days program on Theology and Mission, 75 people attended the College Commencement Service and Library Opening, and another 30 attended a graduation service for the Archbishop's Certificate. In April, 100+ people reserved a place for an evening panel discussion. Each month approximately 20 people attended a research seminar, either in person or virtually, and the College Board meets bi-monthly.

The formation program of the UCA has held some of its events at Wollaston, and their students have engaged with Wollaston formation students.

Other events and meetings, arranged by other diocesan bodies, or related bodies, occurred during the period. These included Clergy Professional Development, Lay Pastoral Ministers' (LPM) Training, Parish Council Workshops, Provincial Council, Diocesan Council and its various committees, Archbishop's Leadership Forum, Enquirers' Program, Vocations Days, Retired Clergy Lunch, Parish of Cottesloe meeting, AngliSchools events and meetings,

Amana Living Training, FDV Working Group meetings, Anglican Board of Mission (ABM WA) meetings, Training in Ministry (TiM) program events, Ministry Review Reference Group meetings, Parish Council Workshops, Tree of Life events, and meetings of the Archbishops' Examining Chaplains and Archbishop's Spiritual Direction Network.

7.4 The Reverend Canon Linda Pilton, Parishes of Woodlands-Wembley Downs and Scarborough

How is the new trauma informed school being developed by Parkerville Children and Youth Care aiming to improve the lives of some of the most disadvantaged children in Western Australia?

Parkerville Grove School, developed by Parkerville Children and Youth Care, aims to transform the lives of some of the most disadvantaged children in Western Australia by creating a specialised, trauma-informed educational environment. Recognising that mainstream and even alternative schools often fail to meet the needs of young people (ages 12-18) who have experienced significant trauma, the School is designed to address the root causes of their struggles. By focusing on rebuilding trust in people and places, and helping students manage complex emotions and psychological responses, Parkerville Grove School breaks down barriers to learning and personal growth.

The School's approach centres on providing access to therapeutic support alongside education, thus directly tackling the poor lifelong outcomes often faced by trauma-exposed youth, such as substance abuse, self-harm, deteriorating mental health, social withdrawal, and heightened risk of homelessness or further harm. Small classroom groups staffed by both education and trauma specialists ensure individualised support, fostering a safe and nurturing atmosphere where students can re-engage with learning and rediscover their potential. Through this holistic model, Parkerville Grove School is committed to giving these young people the opportunity and hope to build brighter, healthier futures.

A Prayer Book for Australia

Introduction - Welcome*

Grace to you and peace from God our Father and the Lord Jesus Christ.

Philippians 1:2

Welcome to Synod. This Synod meeting is the first of three Sessions in the Fifty Second Synod of the Diocese, and that means that there will be people who are here for the first time. Therefore, for the benefit of us all, long termers and newcomers, I will begin by recapping some Synod basics.

We are, as the word Synod itself means, "on the way together", members of the body of Christ, the community of the baptised, and walking as Anglicans in this part of Christ's Church, we consider where and how the Holy Spirit is leading us for the mission of the Church in and for the life of the world.

Synod is the gathering of the clergy and lay representatives of the Diocese with the Bishop to make decisions about our life together in Christ. Each Synod session begins as we gather as the Body of Christ in a celebration of the Eucharist. It continues with our business meetings.

Synod governs our corporate life as Anglicans, and our relationships within the Anglican Church generally, as is evidenced by the business paper of this Synod session.

Synod also brings an Anglican perspective to issues and concerns in wider society, including social and ethical matters, conflict and peace seeking, care of the environment, education, and concern for the most vulnerable among us. While Synod conducts its business on a model based on the Westminster parliamentary system, similar to that followed by federal and state parliaments, we are different. As with parliaments, each Synod member is elected for a term, usually of three years. Each Synod consists of three sessions, one session is held each year.

Synod members elect most members of Diocesan Council, and representatives on wider church bodies, including General Synod and Provincial Council. Over the years, Perth Synod has deliberated on, prayerfully considered, and made decisions on many important matters: parish governance; safe ministry practices; promoting, enabling and resourcing mission; keeping informed about diocesan finances and budgets; encouraging, and sometimes implementing change, in a variety of areas of our life.

Along with newly elected Synod members, we also welcome those clergy newly arrived and ordained in the Diocese of Perth in the last 12 months; The Reverend Canon Jan Joustra, The Reverends Raphael Beuthner, Sylvia Grevel, Rob Imberger, Rhys Roberts-Brown, Cecilia Strutt and Thomas Pote.

As is our custom, there will also be time later in the day to acknowledge and farewell those who have retired from full-time ministry during the past year. We give thanks also for lay leaders retiring from Diocesan posts, among them Mr Ian Hardy, St George's College, and Mr Mike Brown, Operations Manager Diocesan Office.

The Anglican World

The last 12 months have seen several significant events in the Anglican world.

One was the resignation of the Archbishop of Canterbury, Justin Welby, in November last year. His resignation came as a shock, following allegations of the mishandling of abuse in the Church of England. We in the Anglican Church of Australia know only too well the harm done by failure to adequately address abuse.

Now, for the first time in history, the Crown Nominations Committee included representatives from each of the five regions of the Anglican Communion. On 3 October, the appointment was announced of The Right Reverend and Right Honourable Dame Sarah Mullally, as the 106th Archbishop of Canterbury. Bishop Sarah is currently the Bishop of London and will be enthroned as the Archbishop of Canterbury in March 2026. While Bishop Sarah's appointment has been met in the main with acclamation and support there are some in the wider Anglican Communion who are making clear their disapproval of her appointment. This is based on the ground of both her gender, and the leadership role she had as the Church of England worked through their *Living in Love and Faith* agenda. Her appointment and leadership bring into sharp focus the issues of division across the Anglican world.

Over the last three years the Inter Anglican Standing Commission on Unity, Faith and Order (IASCUFO), a permanent commission of the Anglican Communion whose brief is to advise the Instruments and member churches on matters of doctrine, ecclesiology, liturgy, canon law, and ecumenical relations, has been working on a proposal looking to renew the Instruments of the Anglican Communion. These Instruments are the Lambeth Conference, Primates' Meetings, Archbishop of Canterbury and the Anglican Consultative Council.

In Advent 2024, the Commission published a document known as the Nairobi-Cairo Proposals, 'Beginning a New Conversation - Proposals offered to the Anglican Communion' (The Nairobi-Cairo Proposals). These Proposals have been written for consideration to the whole Anglican Communion family, providing ways forward intended to help Anglican churches navigate difference and divisions, upholding the call of all Christians to sustain the unity of the Church. The proposals will be discussed at the meeting of the Anglican Consultative Council-19 in June 2026. While the Archbishop of Canterbury is President of the Council, the meetings are chaired by an elected chairperson, currently Canon Maggie Swinson.

IASCUFO is a wide-ranging and representative group, involving members from different parts of the Anglican Communion in Africa, Asia, South and North America, Europe, and the Pacific. Bishop Richard Treloar, Bishop of Gippsland, is a member. Australia is part of the Pacific region.

Closer to home, Archbishop Geoffrey Smith, Archbishop of Adelaide, announced his resignation as Primate of the Anglican Church of Australia with effect from 30 October 2025. The Right Reverend Dr Mark Short, Bishop of Canberra Goulbourn, was elected as Primate beginning 1 November 2025. I look forward to welcoming our next Primate to Perth sometime in the future.

A Season of Hope

God of Hope you call on us to be your witnesses in this uncertain world; by your Spirit awaken in us a true vision of your kingdom, a greater certainty of our salvation, and a deeper dedication to your service; that through our words and actions the same Spirit may bring many who are lost to be found, and for them to celebrate the hope that we can only have in Jesus Christ, in whose name we pray. Amen.

In so many ways we gather at this Synod under the sign and theme of hope. This year has been celebrated by Anglicans all around Australia as together we committed ourselves to HOPE25: Hope in an Uncertain World, an initiative that was born from the General Synod's call to make evangelism a strategic priority for our life together. Across Australia, parishes, schools, agencies and dioceses were invited into a season of prayer, of witness, and of active proclamation of the Good News of Jesus Christ.

Here in our own part of the vineyard, parishes, schools and other communities discerned anew what it means for us here and now to be a people of hope. We came to HOPE25 not wearing rose coloured glasses about the world or ourselves, because we all know the uncertainties that press on every side, the fragility of international peace, the shaking of democracies, the wounds of creation, and the struggles within our own communities. But, in places all around the Diocese of Perth, people chose to participate in Hope25 because we know that hope in Christ is not a daydream, or a fantasy, nor another feel-good hard sell. It is not our invention. It is God's gift to the human heart.

In 2 Corinthians chapters 3-4, Paul reflects on the ministry entrusted to him among the Corinthians. He reminds them that they themselves are his letter of recommendation, not written with ink or carved on tablets of stone, but written on human hearts by the Spirit of the living God. Their very life in Christ is the testimony to the work of the gospel. This ministry is described as one of hope, for the light of the gospel shines with clarity, revealing in the face of Christ the knowledge of the glory of God. Though the world may be blinded, Paul says, God has shone into our hearts, giving us this radiant knowledge. Like Paul and his companions, we too know that the power of this gospel does not rest in human strength but in God. Paul uses the image of a "clay jar" to highlight his point.

The hope we have in Christ is so very powerful for us because we know, as did Paul and those early Corinthian believers, that we are like fragile clay jars, easily broken, yet entrusted with the priceless treasure of the gospel. The hope we have in Christ is God's gift, displayed in our weakness. The image of hope as resilience, even in the face of fragility is powerful.

Biblical scholar Dr Paula Gooder, who was with us in the Diocese over Holy Week and Easter this year, emphasises that Corinthian society was well known for its pottery. And, while some vessels were what we would call inferior, easily cracked, they were still highly functional for diffusing light. Paul, she suggests, intentionally evokes this image: that our weakness is the very medium through which God's light shines.

The cracks in the jar are not so many defects to be hidden. Rather, they're essential to revealing the treasure inside.

What a profound message that is for Christian communities like ours today! Our personal and communal weaknesses - our failures, anxieties, and limitations - do not disqualify us from displaying God's glory. Rather, these vulnerabilities allow God's grace to shine more clearly. Our weakness can be the very space for grace.

"We have this treasure in clay jars, so that it may be made clear that this extraordinary power belongs to God and does not come from us" (2 Corinthians 4:7).

I love this image, in part because I know it applies to me. But I suspect we all relate to the clay jar image because we know what it's like to be ordinary, breakable, unimpressive, easily chipped. Yet within us is the treasure of the light that shines in the darkness, and is always, always, always stronger than darkness.

This metaphor has resonance in the HOPE25 mission. As congregations, many of us face declining resources, ageing leadership, or uncertain futures. Yet our frailty is not a weakness to lament, but a channel for God's power. Even our ordinary efforts, prayer groups, study circles, pastoral visits, youth mentoring, outreach programs - all these can shine with God's light, because the treasure within us is God's, not ours.

This is who we are. Ordinary people, fragile communities, vulnerable institutions. And yet we are stewards of the precious treasure that is God's astoundingly beautiful gift.

Through the prayers, studies, plans and actions of so many of you through HOPE25 activities, the light of Christ has shone anew in the hearts of many, many people. The bishops have been incredibly fortunate to be part of many of the activities that took place. Parishes held neighbourhood welcome days, intentionally invited people to church, or to a church event; or went to local community events with blessings and information about how the church is part of their local community.

Bishop Kate tells of events in the Parish of Gingin-Chittering, and a Saturday lunch at the "Archbishop's table" in Holy Trinity Church, Chittering. Pews were turned sideways and long tables set up. "A simple fare of soup and bread preceded our guest speaker and allowed us to bounce questions around. This was a real treat for us."

"A Shearing Shed Children's Service on a fifth Sunday of the month in an old shearing shed, cleared out but still smelling of sheep, on a cold stormy Sunday morning with rain and hail on the tin roof. A cross and candles stood on rusty 44-gallon drums. Hay bales for seats and blankets on the slatted wooden floor. This was our church for the day. Thirty good folk including 10 children enjoyed a lay led children's service followed by crock pot lunch. Smiles and delight were all round. Singing to guitar with pauses in bursts of heavy rain on the tin roof. Warmth and fellowship abounded. It is good to remember that the church is where (ever) we gather."

Bishop David writes about the Parish of Canning's Open Day; "The Parish of Canning held an Open Day on Saturday 17 May. The event focused on the dedication of their Purple Bench with the Mayor unveiling the bench and Bishop David blessing it. Both the local State and Federal Members along with many community groups were present. The Parish Op Shop had a big sale and there was a home baked goods stall as well as a Coffee Van run by Cana Communities. Inside the church were several displays and

a prayer station. Anglicare WA ran their Standing Together training. It was a terrific display of love for the community from the church".

Speak with Bishop Hans and The Reverend Dr Eleanor O'Donnell about walking 115kms on the Pilgrimage of Hope with more than 400 students, and the conversations that were possible with young people who want to talk about matters of deep meaning and importance: about the place of hope in their lives.

HOPE25 has been an invigorating time for many and has brought to light new ways in which we can share with others the hope within us, precisely because we know the power of God's amazing grace, welcome, and love, as our true home.

Anniversaries

This year, the global Church is also keeping an anniversary of deep significance: 1700 years since the ecumenical Council of Nicaea in the year 325. That Council began a process that led to the Nicene Creed, a confession of faith. For 1700 years Christians have stood and said this creed together. These are words that are larger than us, words that carry us when we falter, words that have shaped the faith of countless multitudes. They are the words of our orthodoxy – shared with Christians of many traditions.

When we say the words "We believe", we put our trust in the Triune God, rather than ourselves. We put our trust in the God who is faithful, no matter the day, the season, or our own wavering and doubts. "We believe in one God, the Father, the almighty ... We believe in one Lord, Jesus Christ ... We believe in the Holy Spirit ..."

Week by week, we Anglicans, along with millions of other Christians worldwide, stand and say these words. They're not only abstract formulas; they are also declarations of trust. Across the centuries, in times of persecution, famine, war, reformation, and renewal, the Creed has been a scaffolding, weaving together great themes of the biblical witness. On this scaffolding, Christians have faithfully built lives of hope and love.

Across the Diocese, small groups, online Bible studies, and confirmation courses have been quietly forming disciples. A young adult recently reflected after confirmation: "I don't understand everything in the Creed, but I know I want to grow into it". Paula Gooder reminds us, "Christian life is not about acquiring ideas but about being reshaped into a people of hope".³

We are, without doubt, living in a season of global disruption and uncertainty. In it, we are called not only to recite the Creed, but also to live into it. We are called to allow its vastness to expand our faithful imagination, and to let its hope-shaped vision guide our mission. It points us to a horizon, a vast landscape into which we grow. Rowan Williams put it like this, "The Creed is not a checklist but a map; not an exam we must pass but a landscape we inhabit." A generous orthodoxy indeed.

This year also marks the 175th anniversary of the Anglican Board of Mission (ABM). This is the subject matter of one of our motions. We in Perth have always been very supportive of the mission work undertaken in so many parts of the world under the auspices of ABM.

Many of us will remember having an ABM mission money box, the annual Lenten visit of a mission partner, and are supporting mission through 'Church to Church' partnerships. This includes our support of the disability project in the Diocese of Eldoret. ABM continues to develop and work with partners in many countries, and this year many of you will have supported the appeal for the Anglican hospital in Gaza.

Some of our Synod motions make clear how engaged we Perth Anglicans are with the big issues in the world, and the ways in which God's love is made known in so many challenging circumstances. As Anglicans, we consider every challenge in the light of faith and reason and prayerfully make our responses to them.

The 40th anniversary of AngliSchools this year has highlighted the vibrancy of our work with young people in our schools. We have seen afresh the impact of Anglican identity in our mission priority with children and young people. Students, families, and staff are responding to the ministry of pastoral care, the work of chaplains, the excellent curriculums and the strong Anglican leadership that are the hallmarks of all our schools. Each of the bishops has had significant involvement in the spiritual life across all the schools, both AngliSchools and our independent schools.

I acknowledge and thank Principals and Council Chairs who are committed to our partnership in the gospel as educators in Anglican Schools and leaders in the wider Western Australian community.

Alongside those who lead in our schools are leaders in so many areas of community concern. I think of Parkerville Children and Youth Care's response to and support of more than 12,000 children and young people because of family trauma associated with abuse. The Diocesan Secretary and I have now visited the site of Parkerville's planned Therapeutic School which, when complete, will offer real options for young people living with significant trauma. In the face of these and other matters our prayerful support of the wider actions of Diocesan life count.

A Wider Lens

The big picture of mission and ministry in the Diocese of Perth is rosier than we often notice, and it is not all as rosy as we would like. As your Archbishop, I enter the life of smaller and larger suburban and rural parishes in various ways, and I notice both the highs and the lows.

The highs include Sunday and festive occasions, pastoral meetings with parish clergy and lay leaders, hearing from parishes about your plans for community connection, creative responsiveness to changing local community needs, because neighbourhoods change over time. I get to hear, see and celebrate with people across the Diocese as you respond to God's call, collectively and individually.

During this, also on the strongly positive side, what I see and experience and receive is a steadfast faithfulness and continual openness to being Christians in the world; to being communities of hope, nourished by the round of liturgical worship that is our shared inheritance as Anglicans. I see you living this with a generous welcome that touches people.

Along with this, I also bring to my prayers my observations of parishes which are sitting with ageing congregations and diminishing numbers. There is an ache, about what people would like to be, and don't feel that they are, anymore. This is the not-so-rosy part of our life together. We are not always eager to invite the Holy Spirit in, despite our desire to reshape and reframe and redefine our past ways of doing community or being church. In a world that is changing so rapidly, we grieve for what no longer works as well as it used to, when we try to get our message across to society. We can no longer make assumptions that our local community will be tuned into us.

Yet community leaders continue to look to the Church for spiritual wisdom in these changing times. This challenges us to strengthen our spiritual muscles and refresh our theological identity, so that we will always have significant spiritual wisdom to offer and can point to the Lord Jesus Christ as the source of the energy for what we do well. German pastor and theologian, Dietrich Bonhoeffer writing from prison during World War II said, "The Church is only the Church when it exists for others". 5 In other words, hope becomes visible in service.

In several parishes, volunteers prepare food parcels every week, some supported by Anglicare's emergency relief programme which makes significant funding available through our partnership with them. One regular recipient of this relief outreach said: "It's not just the food. It's that people here remember my name".

This year, Anglicare WA and St Bart's have once again responded to the issues of rising homelessness and housing stability and affordability, working with government and local councils to provide safe housing, and to raise their voices in advocacy.

The Amana Living report tells us that more than 9,000 people have been supported through their work, work done by a further 2,500 people. Meath Care also operates across residential aged care, home care, transition care, dementia and Alzheimer's support for individuals and families. This is vital work and service in our communities.

So, we don't need to be anxious about what's not happening, or what we can't do. Please don't fall for the myth that "unless we're doing something AMAZING, we're not doing anything." Instead, let something other than anxiety be your companion. Instead, allow trust to be your friend: trust that our heavenly Father knows what we need before we ask; certainty that the Spirit will keep putting new mission opportunities in front of us; confidence that Jesus will continue to nudge us in the direction he wants us to go.

Now, all the Spirit's new initiatives will not happen everywhere on a neat timetable. Change does not roll out with smooth uniformity. The direction that the Lord Jesus chooses for us is not always towards the goal we had set our hearts on. But the gradual reshaping of our life as a Diocese is not a competition. When we count our blessings, we count those of our neighbours as well as our own, as we are called to rejoice with those who rejoice.

Rejoice with me in the impact of big events; the centenary celebration in our Cathedral, of the ordination The Reverend James Noble, the first Aboriginal man to be ordained in Australia; the State funeral of World War II veteran Arthur Leggett OAM. Rejoice with me in the inauguration of the new Parish of Lake Joondalup and dedication of St Monica's, a long-held dream for the Dinka-speaking Anglican community.

Rejoice with me in the English language classes for new migrants at St Mary's, West Perth. Rejoice with me as I think of the hospital chaplain who described sitting with a patient who asked, "Where is God in this?" The chaplain replied, "Right here with you". Their conversation went on. That is evangelism. I think of the aged care chaplain who recently took time with a man in his 80s to talk about Jesus and then helped that person prepare for baptism and confirmation.

Rejoice with me in the successful relocation of over 30,000 books from Murdoch University and the opening of the Wollaston Library. Rejoice with me, then, in meeting people in their early teens and in their 80s, often from very small communities, who have had a new experience of God's love in their lives through Jesus. Let's rejoice together at the progress on redeveloping the parish plant and mission at Spearwood.

Let us rejoice together with new initiatives in schools for discerning vocational pathways and providing training and theological education. Let's rejoice together with new certificate courses and graduate studies being taken up at Wollaston Theological College. Let's rejoice together when smaller parish communities agree to partner with each other and share people and resources. Let's rejoice together about these and all the other signs that God is with us.

It is so good to be able to report that the work of the Reconciliation Action Group has borne fruit and our Diocesan plan has been accepted. It seems that we are already a long way down the path of the RAP. Thank you to the members of the working group for your commitment to this project and the attention to detail which has brought this work to fruition.

Walter Brueggemann wrote that hope is "the daring act of imagining the world as though God's promises are true." That daring imagination leads us to challenge violence and seek reconciliation. This is long work which needs a constancy in faithful witness and action. In declaring God's constancy, God's desire for the world, for his children of every place, every tribe, every language and nation to be brought together under the wings of his love. Many people are fearful about the world, about the absence of peace, which can, in turn, contribute to a sense of anxiety in our own communities, families and intimate circles.

Working together in kindness and for good, even on a small scale, is such a sign and witness of the reconciling love of God in action. Theologian, Lesslie Newbigin reminds us, "The business of the Church is to tell the story which will give meaning to the whole of life". Here in the Diocese of Perth we proclaim hope by telling the story of Jesus, risen and alive.

The world may seem fragile, broken, or even hostile. Yet God's treasure endures. God's promises remain. Our hope is living, visible, and active. And through our own shortcomings and vulnerabilities, we shine God's light into a world that desperately needs it.

This Synod time in which we walk together, gives us through our prayer, conversation, and consideration of the business before us renewed hope in Christ. It offers strength, as we hold together into the loving heart of Jesus Christ for our mission and ministry. We travel on, not as perfect disciples, but as faithful ones.

I thank Bishops Kate, David and Hans and their families for their prayerful and caring ministry among us, and for their humour and joy in the life we share together.

My thanks go to the Archdeacons. I want to record our thanks to recently retired Archdeacon of Perth and Archbishop's Registrar, Archdeacon Angela Webb. Angela has been a caring, prayerful and faithful minister of the gospel as she has fulfilled the demanding role of Archdeacon of Perth. When resources are stretched, she has picked up extra duties and responsibilities for the wellbeing of our clergy and parishes without complaint. Over the year her work often includes some of the thankless tasks of following up with clergy and parishes when they run late or do not furnish evidence of safe ministry clearances, parish returns, leave forms, financial information, faculty details and the like. Angela also picked up most of the work seeking locums and supply.

As she has laid this ministry down, it has been a joy to welcome Archdeacon Justine Coverdale to her new role as Archdeacon of Perth, with some shared time alongside Angela for handover. Justine is now sitting comfortably in her new role. Archdeacon Justine is also working alongside Bishop Kate in the Gnamma Archdeaconry. I know many of you are getting to know her as you speak with each other.

It has been a blessing to have welcomed The Reverend Jacob Legarda back to the Diocese and to a part-time role as Archbishop's Chaplain once again. Thank you, Fr Jacob for your prayer and practical support. It is much appreciated by me, by the staff in Church House and the diocesan clergy and lay leaders amongst whom you minister.

Archdeacon Kathy Barrett-Lennard OAM retired earlier this year. Kathy's capacity to be everywhere in the rural region of the Diocese is something which Bishop Kate is considering as she looks to future ministry developments in the rural and regional centres.

Archdeacons Mandy Herriman, Peter Boyland, Gillian Rookyard and Clive Hillman each fulfilled different areas of responsibility including territorial archdeaconries, deacons, those new to the Diocese, formation and training, those newly ordained as well as clergy wellbeing. I thank him for his tenacity and perseverance alongside the Dinka community as we moved toward the Parish of Lake Joondalup.

Dr Megan Warner's creative and strategic leadership of the Wollaston Theological College, aided by her academic depth and professionalism, is a great boon to the work of the College and the Senior Staff leadership group.

The Reverend Grahame Bowland continues to work, albeit very part-time, in the Episcopal Office further developing the Diocesan App. We thank him for all that he brings to this role for mission 'on the ground'.

Thank you for the leadership you all bring in this season of our life together.

I am blessed to work with the staff in the Episcopal Office, so ably led and overseen by the Manager Episcopal Services, Mrs Susan Harvey. Susan oversees a very heavy load continuing to manage arrangements for the Episcopal Office with a minimum of fuss. It is so good to know that Susan is a trusted point of contact for Archbishop's Office. Mrs Melanie Hare now works as the Personal Assistant to Bishops David and Hans. Together Susan and Mel are welcoming, helpful and so very positive in their approach to all they do. Ms Cailin Hovell has returned to the Episcopal Office as Administration Officer and will soon be offering more support to Bishop Kate. Their hard work is undertaken with a wonderful attitude of service, and I thank God for all of them.

The Chancellor, Mr Eric Ross-Adjie, as Chair of the Legislation Committee works in conjunction with that Committee to bring legislation to Synod. He also oversees the numerous matters which need consideration by and referral to the Chancellor across any given year. It is a blessing to have a Chancellor whose faith in Christ, prayers and loyalty to the office of the Archbishop and diocesan life is unwavering.

The Diocesan Council continues to work with the good of the Diocese at the centre of its business as it oversees a wide agenda of strategic mission overseen by commissions, redress, policy, finance, parish property, wider governance matters. I thank the members of Diocesan Council for their careful consideration in those times when the matters before us are difficult, as well as in those in which it is easier to discern the leading of the Holy Spirit.
