Important Update to Volunteer National Police Checks

A gentle reminder below of ID verification required by the Safe Ministry Team to lodge an updated VNPC for you:

- Form to be used: [Crimcheck Application Form](#)
- Copies of ID required (as set out on Page 2 of the form):
 - Commencement Document (Passport / Birth Cert / Visa)
 - Primary Document (Driver's Licence)
 - Secondary Document (Medicare Card / Marriage or CON Cert / WWCC)

If you have any outstanding requirements, please ensure any documents are received via the Screenings email no later than **Friday, 27 February 2026**.

Working with Children Check (WWC)

WWCC remains a legislated requirement for anyone involved in child related work. Key updates from January 2026 include:

- Updated factsheets, guides, and forms available through the WA Department of Communities' WWCC Resources and News Portal search "WA WWC" or see link below.

 - Online processes enable card renewal, replacement, detail updates and validity checks directly through the portal.
 - Remember if you hold a WWC card you are required to advise the WWC Screening Unit of any changes to your personal details and work circumstances.
