## **24. Composition of Committee**

- (1) The Management Committee consists of –
  - (a) An Association President; (Chairperson)
  - (b) An Association Vice President (Vice Chairperson)
  - (c) a Secretary;
  - (d) a Treasurer;
  - (e) a representative to the Australian Bowhunters Association - Branch A committee. (ABA Rep);
  - (f) a Club Score Recorder; and
  - (g) a Club Range Master.
- (1) Unless elected directly as a separate office holder, the Committee must appoint one committee member to be the Association's public officer.
- (2) Members appointed to the following positions shall be ex-officio members of the committee;
  - (a) Club Risk Management Officer;
  - (b) Club Bowhunting Education Officer;
  - (c) Club Game Measurer;
  - (d) Club Coach

### *Division 2 – Tenure of office*

## **26. Eligibility of committee members**

- (1) A committee member must be a member who is 18 years or over.
- (2) A committee member must also meet the criteria provided in the Schedule.
- (3) Committee members must be elected to the Committee at an annual general meeting or appointed under clause 33.

**27. Nominations for election to committee**

(1) A member is not eligible for election to the Committee unless the Secretary receives a written nomination for that member by another member not less than 7 days before the date of the next annual general meeting.

(2) The nomination must be signed by –

(a) the nominator and a seconder; and

(b) the nominee to signify his or her willingness to stand for election.

(3) A person who is eligible for election or re-election under this clause may –

(a) propose or second himself or herself for election or re-election; and

(b) vote for himself or herself.
