Summary:	Applications are invited for the position of Team Manager and an Assistant Team Manager to assist with the 2019 Western Suns Pool Rescue State Team at the Interstate Championships 9 - 11 August, 2019, Gold Coast Aquatic Centre, Southport, QLD
Action:	Clubs are to advise individuals of the opportunity. Individuals are to submit nominations to Andrew Mosel at SLSWA, by 5pm Friday 7 th June 2019.

SLSWA is calling for nominations for a Team Manager and an Assistant Team Manager to assist with the selection of the Western Suns Pool Rescue State Team and attend the SLSA Pool Rescue Championships 9 - 11 August, 2019, Gold Coast Aquatic Centre, Southport, QLD. These positions will also be required to assist with State Team operational requirements.

Successful applicants must meet the following requirements:

1. Be a current and financial member of a Western Australian Surf Lifesaving Club.
2. Observe competitive performances/results at the 2019 WA SunSmart Pool Rescue State Championships.
3. Be present for any official Team Manager meetings/briefings held by SLSA throughout the SLSA Interstate Championships.
4. Sound knowledge of Pool Rescue rules and regulations are desirable for potentially lodging protests.
5. Previous experience as a Pool Rescue athlete, official and/or coach is desirable but not essential.
6. The successful members will be responsible for their own travel and accommodation arrangements in relation to their participation in the team.

SLSWA Support

SLSWA will provide each selected member with a \$400 (inc GST) subsidy to assist with associated travel and accommodation costs. The subsidy will be paid to the member's club at the completion of the championships and the club will be responsible for distributing these funds in accordance with individual club policy.

After the close of nominations, the appointment of Team Management positions will be finalised and successful nominees will be notified. All appointments will be posted on www.mybeach.com.au. Nominations are to be returned to Andrew Mosel at SLSWA by 5PM, Friday 7th June 2019.
