The SunSmart WA Pool Rescue State Championships are being held at HBF Arena Joondalup over the weekend of 26 & 27 June 2021 with events on Saturday 26 June starting with warm up at 10.30am and at 7.30am on Sunday 27 June 2021.

Entry Information

Entries will close at 5pm Friday 18 June with no late entries accepted.

Entry to the Championships is to be done through the online Carnival Manager System.

All Competitors must have their relevant Competition requirements to be eligible to compete which is up to the club to enforce. Random checks will be carried out to ensure this.

Entry is \$40 per competitor.

Entry into the Pool must be paid by the competitor and spectators.

No Mixed Club Teams are allowed to compete.

Competitors in the Patient Tow with fins must be in the same age group ie: no U10 can compete in the U11 Patient Tow with Fins

All clubs will be allocated timing duties and Pool setting duties which will be given to clubs on Thursday 24 June 2021 via SLSWA Surf Sport Team App and Club Administrators/Competition Managers.

Medals and Presentations:

Medals will be presented throughout the day at the Dais Presentation area next to the Announcers table.

All events require a minimum of 3 competitors/teams from 2 clubs to be declared an event.
