Travel & Accommodation

SLSWA will provide:

- Up to 4 air tickets respectively for Broome, Dampier and Esperance Goldfield SLSC to be organised by the Country club delegate by no later than Friday 28 August 2026.

Country club delegates from Broome, Dampier and Esperance Goldfield SLSC to book a '[Resident Fare Ticket](#)' directly with the respective airlines. Though the Regional Airfare Zone Cap scheme, delegates will be able to book flights at the reduced capped fare price.

Tickets can be booked through the respective airlines below:

- **Qantas Airways** - visit [Discounted fares for residents | Qantas AU](#) or call 13 13 13 – you will need your Qantas Frequent Flyer number to book.
 - **Virgin Australia** - visit [Regional flights - Discounted Virgin Australia fares for residents](#) or call 13 67 89 – you will need your Velocity Frequent Flyer number to book.
 - **Rex** - visit [Rex](#) - the resident fare price option will be displayed when you search for your flight.
- Car hire allowance will be paid to Broome, Dampier, and Esperance Goldfield SLSC capped at \$250 per car (Maximum one car).

Temporary Increase in Fuel Subsidy for September Travel

In consideration of the ongoing fuel shortage and the resulting increase in fuel costs, SLSWA will temporarily adjust the fuel subsidy for the September Forum to help offset the higher fuel expenses currently being experienced.

- Fuel allowances will be paid to country club delegates as follows:
 - Albany, Champion Bay, Denmark, Dongara Denison, Geraldton, Margaret River and Smiths Beach fuel allowance capped at \$340.00 per car (Maximum of two cars).
 - City of Bunbury, Dalyellup, Busselton and Binningup fuel allowance capped at \$200.00 per car (Maximum of two cars).
 - Port Bouvard, Secret Harbour, Mandurah fuel allowance capped at \$95.00 per car (Maximum of two cars)
- An accommodation subsidy of \$250.00 per person for the Friday night prior to the meetings will be provided for 1 country delegate attending each meeting, i.e the subsidy will be for a maximum of 4 people per club (excluding Port Bouvard, Secret Harbour and Mandurah). Where unique circumstances apply (eg a flight cannot be arranged for Saturday afternoon) we will also provide the same subsidy for the Saturday night.

We have taken on board feedback received from delegates in respect to the inflexibility of having their accommodation arranged for them in previous years; individual delegates will now be responsible for arranging their own accommodation.

To receive their subsidy clubs are to invoice SLSWA by no later than 30 September 2026 attaching copies of relevant receipts. Club delegates to provide copies of relevant receipts to their respective club for reimbursement.
