Park Road/Merton Road intersection pedestrian crossing - Community safety concerns


I refer to page 66 of the Infrastructure Committee section, and page 92 of the General Business section, of Council minutes of 2 September in which the issues of Council intersection upgrades, safety risk and community demand are addressed.

The Dutton Park State School P&C is grateful for the opportunity to bring the Park Road pedestrian crossing to your attention for action. This is the intersection addressed by Cnr Massry at page 92. We have long been advocating to have this crossing upgraded. Our request is to move it off the crest of the hill to the other side of Merton Road and to install traffic lights. I have attached a map and close up of the location for your reference at the end of my letter.

Many of our families use this crossing on a daily basis, and it presents significant safety risks for pedestrians. The intersection is also a common site for incidents between motorists attempting to enter Park Road from Merton Road into fast, oncoming traffic. Other safety issues exist, such as the access to the Gabba Hill side streets by "rat running" vehicles at speed.

Park Road is used by vehicular traffic to travel between two major roads — Annerley and Ipswich Road and as a short cut down Merton Road to the freeway access off Stanley Street. Vehicles regularly speed. It is used by local school children to attend school and by other pedestrians to access Park Road Station and the busway. The public transport options will soon become part of the second largest public transport interchange in Queensland. The crossing is located on the crest of a hill which makes visibility extremely problematic, especially in the late afternoon and early mornings when the sun is in motorists' eyes. The crossing is supposed to be monitored during school transit times by a crossing supervisor. However currently the role is not filled and has been vacant since July. The role poses significant safety risks to the holder.

We have explored a variety of options with Council which have been rejected due to the high speeds of the traffic on the road (eg wombat crossing). Our local Councillor has successfully advocated on



our behalf for more paint markings on the road which were installed in the last year. She is also working with Council on the question of whether flashing lights can be installed from her Ward budget. Our local State member has been assisting us with our advocacy to Transport and Main Roads (TMR).

We are most grateful for this support, but in light of the dangers to our children this crossing represents, we believe a more permanent solution is necessary and we hope you might be able to help with that.

Our request regarding lights has been rejected by Council on the basis that not enough pedestrians use the crossing. We reject this reasoning. The safety risk is extreme and affects many children. Lights would also dramatically assist traffic flows from Merton Road onto Park Road. The use of Park Road will continue to increase due to pressure on roads generally, and its importance as a connection between the above-mentioned other roads and locations. The volume of pedestrians and the need to support active transport in the area will also increase over the coming years with the State's Woolloongabba PDA supporting the development of substantial new apartments on Annerley Road and adjacent locations, as well as the opening of Cross River Rail and expansion of the Metro.

The need is not a future need. The need is now. The location is dangerous and does not currently have a crossing supervisor, ordinarily employed by TMR and the Department of Education. This is not a new scenario. We have had previous issues filling this position. This is not a surprise. The last crossing supervisor reported daily abuse and near misses from motorists in doing his job.

I have attached a chronology for you of the work we have been doing recently to bring this issue to the attention of Council. I have also attached the preliminary results from a survey we are currently running. We commenced this survey when it became clear that TMR is struggling to recruit a crossing supervisor. I will send you updated results when we close it.

Your assistance in elevating this issue would be very gratefully received. We are most grateful to the work that our local Councillor has been doing to date to work with Council to address safety issues within the Ward. This is our highest priority. We have others that we would also be delighted to discuss with you if you have the time.

Dutton Park State School P&C Correspondence

October 2022 Meeting between the P&C, Council and TMR Representatives to discuss road safety and traffic concerns affecting the school community.

27 April 2023 Follow up from the P&C including an invitation to all stakeholders to attend a P&C general meeting.

Discussion between P&C President and Council representative of all issues including Park Road crossing. Our record of Council's advice and our position states:

The intersection on Park Road and Merton St is a known problem area and Council has done all it can to raise visibility. The next step would be to upgrade the intersection to a light but the likelihood of such an upgrade is low because demand for the intersection outside school entry and exit times is low. Ie the need does not justify the cost. We continue to request this upgrade. It is a dangerous intersection, and we suggest that even if the raw demand from school children (from 2 schools) and train station users is not enough to meet Council thresholds, the safety of the location itself should be. We do not want a fatality or significant accident to be the catalyst for an upgrade.

Council Reference 17384627. We submitted a formal request that Council review the traffic safety concerns affected Dutton Park State School. In respect of the Park Road crossing we stated:

The intersection between Park and Merton Roads is dangerous. You have told me that Council doesn't consider there is enough traffic to upgrade to lights. Can we have the intersection assessed for other alternatives such as a wombat crossing that are effective in slowing motorists down? If further upgrades short of lights have been assessed and ruled out, is an alternative relocating the pedestrian crossing away from the peak of the hill for example - on the other side of Merton Road towards Quarry Road and a second one between School and Merton Roads?

TMR having followed up a range of issues for us. In relation to the question of whether the crossing point would be better relocated, they advised:

We did also discuss the request that you had raised about the crossing being moved to the other side of the intersection and away from the crest. BCC had investigated this a few years ago and advised that the pedestrian desire line was around that intersection and moving the crossing would mean that pedestrians would still cross at the same location and not use the crossing. BCC further advised that if the crossing was moved it wouldn't meet the requirements for it to be a pedestrian or zebra crossing and would revert to a children's crossing and may be viewed by the community as a less safer option as it would appear to be less visible.

[We think this needs reassessment as the traffic gets busier and in any event, if a full crossing with a set of lights was relocated, it would get used.]

We increased our engagement with our local police and asked that they include speed monitoring (as well as RBT) in their regular local checks. A record of our approach that I sent to Council at the time stated:

On traffic speed issues, we are grateful for the support of the Dutton Park Police Station and are working more closely with them on traffic issues. As a result of

our discussions, they have built in a regular speed check on the inbound lane of Annerley Road or the descent down Park Road to the Annerley Road lights where parents regularly report speeding. Our perceptions have been confirmed by the Police who gave the example of booking 8 cars in a 2 hour period one morning which is quite significant and doesn't even take into account other noncompliances that were likely to be happening during the booking process.

28 August 2023

Council Reference 17384627. We followed up the status of our request.

7 September 2023 Council responded to our request reference 17384627. In respect of Park Road, it stated:

Council is aware of the concerns raised regarding the existing zebra crossing on Park Rd. The zebra at this location does not meet the current standards under the Queensland Government's Manual of Uniform Traffic Control Devices. Furthermore, the crossing is located at the very top of the crest, which is good for visibility for pedestrians to cross. However, motorists would not see the zebra markings unless they are almost on top of the crossing. As the zebra crossing is already existing, Council has no plans to remove the crossing unless it is supported by the local Cr. It is worth noting that alternate crossing facility types would be limited as the crossing is vastly underutilised outside of school peak periods to justify an upgrade to signals. I can advise Council has all the appropriate signage and line marking on both approaches to the crossing to highlight to motorists the presence of the zebra crossing.

In regards to wombat crossings, I can advise wombat crossings are vertical deflection devices which can be considered as a 'traffic calming' device and, as such, a key objective of the treatment is to moderate vehicle speeds. Taking into consideration of traffic calming guidelines provided in the MUTCD, raised wombat crossings may only be considered when the following conditions are met:

- The location is a local street with a local or limited collector function (ie. Local Street /Neighbourhood Road).
- A speed limit of 50km/h or less applies.
- Traffic volumes are less than 400 vehicles per hour in the peak hour.
- Truck volumes (4.5 tonnes GMV or greater) are less than 50 vehicles per day.
- The longitudinal gradient of the road is less than 5 percent.
- The road does not form part of an access to a commercial development (i.e. industrial precinct).
- The road is not used extensively for access to emergency service establishments, high density residential developments or public meeting place.
- The road does not form part of a bus route unless steps are taken to minimise discomfort to passengers, for example, through the use of long flat-top humps with minimum ramp grades.

Park Rd is considered as a district access route under Brisbane City Council road hierarchy. As such, wombat crossings are not considered to be an option along a road of this nature.

11 Sept 2023

DPSS P&C requested that Council consider whether there are any other ways of slowing the traffic on the Park Road Merton Road intersection and making it safer for children.

17 October 2023

Not further responses from Council.

9 March 2024

In 2024 the DPSS P&C worked with the Gabba Ward office to request speed monitoring along Annerley and Park Roads as the main roads our children cross daily. We were provided with the following advice based on the SAM data:

"The counts provided are just for the school peak periods. As such, all the information is only related to the traffic between 7-9am and 2-4pm Mon-Fri. I would say that the 85th percentile is considered high for school peak periods."

So this means:

- · Park Rd between School St and Merton Rd:
 - Average speed is 39.4km/h
 - 85% of vehicles travel at or below 46km/h. This means 15% of cars are travelling at 47km or above 208 vehicles each day on average are travelling at these higher speeds during school hours
- Annerley Rd between Tillot and Nelson St
 - Average speed is 39.9km/h
 - 85% of vehicles travel at or below 49km/h. This means 15% of cars are travelling at 50km or above 218 vehicle each day on average are travelling at these higher speeds during school hours

And Kiran thinks the 85% number is higher compared to other school zones

Which seems to indicate that there is a greater number of people speeding in both of these zones.

April 2024

DPSS P&C and the Gabba Ward followed up the speed data from BCC and police to request from TMR or BCC:

- TMR install a covert speed camera
- School paintwork on the road
- Flashing lights to indicate the crossing

24 April 2024

The response we received was:

- Led flashing warning signs are not being installed for any existing BCC project
- A proposal to discuss a flashing slow down warning sign could be discussed at the end of the financial year
- BCC was supportive of painted school zone thresholds but due to BCC budget constraints they would not be approved and installed until next financial year [these have since been installed].

24 April 2024

The school crossing supervisor at Park Road resigned and the crossing was unsupervised pending recruitment. Correspondence at the time indicated that recruiting for these positions is problematic.

5 November 2024

With the assistance of the Gabba Ward and on the advice of the new crossing supervisor (Sean) about the dangers of Park Road, we again requested paint marking and SAM speed monitoring data of this intersection be addressed.

13 November 2024

Given the ongoing risks to pedestrians and the abuse being received by the crossing supervisor, the police began assistance with sporadic inspections of the pedestrian crossing.

14 May 2025

With ongoing issues at the pedestrian crossing, we introduced a check in with the crossing supervisor before each month's meeting. In May, Sean said:

I don't like complaining because I love the kids; the families at the school are great but too many other pedestrians, cyclists and car drivers; their behaviour is uncivilised, it's not safe and it's putting people's lives at risk. I grew up on a farm in Ireland where I did all sorts of injuries to myself. I worked as a bouncer in night clubs. I've been shot at, beaten up, dealt with people on drugs. But this is the one job I've had in my life where each morning before I go up that hill, I do wonder if this will be my last. I wonder if today I will be finally hit.


14 May 2025 DPSS P&C raised with the Gabba Ward the increasing frequency with which large trucks are using Merton Road as a thoroughfare, apparently based on Google Maps advice.

Google Maps advice

A formal complaint was made by a parent to the P&C about the treatment our crossing supervisor Sean was receiving both from motorists but also from his TMR supervisor who was attempting to discuss his performance and his uniform at the crossing, at the same time he was supposed to be performing his duties. The parent reported this conduct was jeopardising the safety of both Sean and pedestrians and was done in an appropriate tone and manner. The P&C passed this onto the school.

17 July 2025 DPSS community was informed that the Crossing Supervisor was no longer working at Park Road and that a recruitment process was underway. No one has been recruited.

Location of the Park Road Pedestrian Crossing



Q1 We (I or my children) use the pedestrian crossing on Park Rd near Merton Rd



Q2 I feel pedestrians are safe using this crossing



Q3 I have witnessed or been involved in an accident at this crossing




Q4 I have witnessed or been involved in a near miss at this crossing


Q5 How often do you witness/experience unsafe driving or other behaviour at this crossing?
