I live at the Bellevue on Bellevue apartments on the corner of Hunter and Bellevue Street at the "awful end of town" so I am all for the revitalisation of the city, ending the railway etc as it will make our end of town look much nicer and hopefully increase the value of our property.

However, it seems there are plans for a walkway on the other side of the drain which will be widened and will be a link between Hunter Street and Honeysuckle Drive once the railway stops at Wickham. I assume that this will mean most of the foot traffic from the trains will use that pathway and you have seen the mess they have made of Bellevue st with all the graffiti, and the constant repainting in our street.

I don't know if you have noticed but on Wednesday nights between 11pm and 1am that pathway is used as a public toilet and garbage dump for smashing beer bottles by all the drunken teenagers walking from the Cambridge to uptown. This also happens on Friday and Saturday nights. I have seen these people peeing in the garden, and on the front door of the next door building, vomiting on their front steps and purposely breaking the plants, not to mention all the drunken arguments and yelling.
