Councils response to the attached submission has inaccuracies and assumptions that are factually incorrect.

I didnt ask for my property to be considered in isolation. I asked council to consider rezoning of my area, with reasons provided.

Additionally all traffic leaving Miranda high rise zone 5 will head north and south on Sylvania Rd. As the are no traffic lights at University Rd, Miranda all traffic leaving will head west on The Kingsway and turn into Sylvania Rd to head back east around the block.

I dont use Miranda Station, as my property is 10m from the suburb boundry with Gymea. My family and neighbours use Gymea Station, as access is easier and is only a 10min walk. The F6 if ever constructed will never impede access to Gymea Station. Also I have a bus stop at my door so public transport access to the train station is simple and convenient.

The beginning of the northern low density area has not been extended in all the years that the Miranda Centre and Gymea have been progressively increased. Council in LEP2006 removed the park zoning next to this property without notification and fails to accept these impacts.

- 8. Kouris Hardware is 5 doors down
- 9. A second child care centre has recently been approved half a block down the street
- 10. Council woodchip and other sporting and recreational events are held on the park next door.
- 11. R4 residential is proposed at Pinnacle St/University Rd Miranda
- 12. Traffic lights at Sylvania Rd, The Kingsway and President Ave have been installed
