I am a farmer from Crookwell and one of three landholder hosts of the Crookwell 3 wind farm. I live about 8 kilometres from the wind turbines at the Gullen Range wind farm and see them every day from my farm. There are numerous small farms in this area, particularly between my farm and the Gullen Range wind farm. These farms have been changing ownership over time and the wind farm has not had any impact on the prices they have made. If the wind farm companies are encouraged to share the benefits of the wind farms with neighbours I think this will actually improve the value of these farms. Even though this price rise makes it harder for people like me to buy land next to my farm, I think this is a good thing.

I notice that the draft planning framework documents suggest that there be further assessment of the cumulative impact of wind farms out to 8 kilometres. I think this distance is too much and should be more like 4 kilometres. Please remember that most people actually like looking at the turbines!

The area where I live is very windy and we should be encouraging the development of wind farms here, not discouraging it. This is all very fertile land and is farming and grazing land. Wind turbines can assist farmers such as me to become more sustainable because they take up virtually no land and the passive income helps me when it stops raining, or it rains too much. The more this passive income stream is spread into my area the better off the whole area will be. The planning framework should be considering the positive benefits such as these, not just the interruption of someone's view.

I attended the forum held in Crookwell and was very disappointed that the opponents to wind farms were given much too much freedom in the meeting. I would have liked to ask a question, but there was no time because the facilitator didn't limit these opponents to the 3 minute time. He also allowed them to interrupt and intimidate people who

didn't agree with their opinions. This is not fair.
