Mr Roberts,

I write to express concern on the proposed Cook Cove development as a resident on Levey St, Wolli Creek.

The area through which many use to access the airport and the Cook Cove area/golf club around Marsh St, Gertrude St and Levey St are already heavily congested. Cahill Park which sits between Wolli Creek station and the airport already has high foot traffic is often littered with rubbish and airport trolleys already as pedestrians use the route to avoid paying the Airport access fee. Further, Levey St and Cahill Park is often flooded from high tides from back flow up through the storm drains.

I believe the above needs to be urgently remediated for any consideration for Cook Cove to be developed. The area requires increased council officers and services with increased garbage collection and bins, airport trolley locks and installation of drainage and valves for the storm drains to stop the tidal flooding and footpath upgrades and lighting for Cahill Park for any development to occur. The footpaths and traffic management along Gertrude and Innesdale/Levey St needs to be improved as there are also often cars/coaches/buses waiting along Levey St due to proximity of

Mercure hotel.
