I am a small business operator running a restaurant in Kangaroo Valley. I am writing to express my concerns relating to the option paper for the planning of regulations in Short Term Holiday Letting in NSW.

Having discussed this at length with other members of our local Chamber of Tourism and Commerce, I believe that the majority of issues are related to metropolitan areas and strata properties. I would like to see tighter regulations in strata properties and more legal power to building managers relating to STHL. If the last two options given in the paper were followed through with, there would be a significant impact on our local community and other regional areas.

The tourism sector and its subsidiary businesses (cleaners, fire-wood suppliers, electricians, maintenance services) employs the majority of people who live in Kangaroo Valley. If there were limitations on the operation of small short--term holiday letting properties, the wider community would suffer as a chain reaction to the loss of employment that it could create.

We are lucky as a community to have a school (member of the Small Schools Assoc), doctor (only part time) and pharmacy. To keep the services that the residents need day to day, we need to keep the level of employment constant. If tighter DA requirements were implemented, there could be a back-log in DA approvals (which can already take up to 10 months), significant cost to councils and in turn STHL operators and this would affect the number of visitors staying in the area - which would affect my restaurant.

I am a small business operator running a restaurant in Kangaroo Valley. I am writing to express my concerns relating to the option paper for the planning of regulations in Short Term Holiday Letting in NSW.

Having discussed this at length with other members of our local Chamber of Tourism and Commerce, I believe that the majority of issues are related to metropolitan areas and strata properties. I would like to see tighter regulations in strata properties and more legal power to building managers relating to STHL. If the last two options given in the paper were followed through with, there would be a significant impact on our local community and other regional areas.

The tourism sector and its subsidiary businesses (cleaners, fire-wood suppliers, electricians, maintenance services) employs the majority of people who live in Kangaroo Valley. If there were limitations on the operation of small short--term holiday letting properties, the wider community would suffer as a chain reaction to the loss of employment that it could create.

We are lucky as a community to have a school (member of the Small Schools Assoc), doctor (only part time) and pharmacy. To keep the services that the residents need day to day, we need to keep the level of employment constant. If tighter DA requirements were implemented, there could be a back-log in DA approvals (which can already take up to 10 months), significant cost to councils and in turn STHL operators and this would affect the number of visitors staying in the area - which would affect my restaurant.
