Dear resident,

Murrumbeena to Malvern Flood Mitigation Project – Underground services locating works corner of Wilson Street and Dandenong Road, Murrumbeena.

We wish to advise you of upcoming works to locate underground services as part of the Murrumbeena to Malvern Flood Mitigation Project.

These works will not impact your property or utility services, and access will be maintained.

Location of works

We will be working on the corner of Wilson Street and Dandenong Road, Murrumbeena as shown in red on the map overleaf.

Timing

Our works will occur:

- 7 am to 5 pm Monday 6 March to Friday 10 March 2017
- 7 am to 5 pm Monday 13 March to Friday 17 March 2017

What we are doing

- Excavating to expose underground services using heavy machinery, and a non-destructive digging truck (NDD truck), recording the locations.
- Detouring motorists to safely guide them around our works.
- Allowing for two-way local access only for properties 1256 to 1270 Dandenong Road.
- Temporarily closing the Wilson Street bus stop (ID 11932) for the duration of works.
- Storing equipment and machinery over-night on Wilson Street, and temporarily removing street parking adjacent to 1256 Dandenong Road.
- Temporarily reinstating our work areas at the end of each day, with full reinstatement to occur at the completion of these works.

What you may experience during these works


While these works will not impact your property, you may notice:

- Noise generated from heavy equipment, such as excavators, trucks, road saw,
 NDD truck and site vehicles when in use.
- Traffic management including signage and personnel safely guiding pedestrians and motorist safely around the works.
- Temporary reinstatement of our work areas after each day.

About the project

Melbourne Water is planning to construct a new stormwater drain to minimise the impacts of flooding to properties in Murrumbeena and Malvern East.

The new stormwater drain will collect water from heavy rainfall that flows over the streets and paved surfaces, reducing the impact of flooding.

Melbourne Water has engaged engineering consultants GHD to undertake the functional design phase of the Murrumbeena to Malvern Flood Mitigation Project.

We are working closely with City of Stonnington and Glen Eira City Councils, locally affected residents and other agencies to minimise any inconvenience to residents throughout the project.

This work may be rescheduled in the event of unsuitable weather or other unavoidable circumstances. We apologise for any inconvenience and appreciate your understanding.
