Circulation

- C1** MAIN SHARED TRAIL ENTRANCE & LINK TO MELTON TOWNSHIP.
- C2** RESIDENTIAL BOULEVARD WITH COPENHAGEN STYLE BIKE PATH FOR COMMUTER CYCLISTS.
- C3** SECONDARY PATHS THROUGH OPEN GRASSLANDS & WETLAND BOARDWALKS.
- C4** MAIN TOOLERN CREEK TRAIL PASSES UNDER & CONNECTS TO PROPOSED EAST-WEST ARTERIAL BRIDGE.
- C5** SOUTHERN TRAIL ENTRANCE TO THE PARK. MAIN SHARED TRAIL TO FOLLOW STRATH-TULLOH CIRCUIT SOUTH TO CONNECT WITH PROPOSED WERRIBEE RIVER TRAIL.
- C6** INFORMAL TRAIL ACCESS ONLY TO SOUTHERN END OF SITE DUE TO CHALLENGING SLOPES & FRAGILE ROCK ESCARPMENTS.

Activities

- P1** NORTHERN PICNIC AREA WITH INTERPRETIVE REFERENCE TO HISTORY OF ABORIGINAL USE & EUROPEAN HOMESTEAD. SHELTER, SEATING, PICNIC AREAS & ACCESS TO LOWER CREEK LEVEL CLEARINGS.
- P2** NORTHERN SPORTING FIELDS (10 HECTARES) WITH ASSOCIATED PARKING (60 SPACES) & FACILITIES SUCH AS AMENITIES BLOCK, KIOSK, SHELTERS AND SEATING.
- P3** PICNIC AREA WITH HISTORIC HOMESTEAD ELEMENTS, TOILET & CHILDREN'S NATURE EXPLORATION PLAY AREAS. POSSIBLE FUTURE PEDESTRIAN BRIDGE CROSSING TO ACCESS WESTERN CREEK EDGE.
- P4** SOUTHERN SPORTING FIELDS (8 HECTARES) WITH ASSOCIATED PARKING (60 SPACES) & FACILITIES SUCH AS AMENITIES BLOCK, SHELTERS AND SEATING.
- P5** CENTRAL PICNIC FACILITIES & CHILDREN'S NATURE EXPLORATION PLAY AREA WITH PARKING, SEATING, SHELTERS, ETC.
- P6** VISITOR FACILITIES & ENTRANCE INTO GREY BOX CONSERVATION AREA.
- P7** REGIONAL ADVENTURE PLAYGROUND ADJACENT TO VISITOR NODE AND PARKING.
- P8** ENHANCE NATURAL HIGH POINT ON SITE BY UTILISING WETLAND CUT AS FILL FOR A BUILT UP VIEWING MOUND.
- P9** LOWER CREEK LEVEL CLEARINGS WITH INFORMAL ACCESS TRAILS.
- P10** SOUTHERN SECTION OF THE PARK HAS DIFFICULT ACCESS, WHICH MEANS INFORMAL TRAIL ACCESS ONLY. FLEXIBLE PROGRAM FOR ACTIVITIES SUCH AS: HIKING, ORIENTEERING, BOULDERING, BIRD WATCHING & GEOCACHING.
- P11** HISTORICAL CONSERVATION SITE WITH INTERPRETIVE & EDUCATIONAL OPPORTUNITIES AROUND HOMESTEAD RUINS.

Environment

- E1** CREEKLINE HABITAT CONSERVATION & REHABILITATION. PREVENT EROSION BY DISCOURAGING CLIMBING/HIKING AND MOTOR/MOUNTAIN BIKE ACCESS IN FRAGILE AREAS. LOWER CREEK CLEARINGS PRONE TO FLOODING AT HIGH FLOWS, BUT INFORMAL ACCESS ALLOWED IN DESIGNATED AREAS.
- E2** STORAGE & TREATMENT OF RUNOFF FROM FUTURE DEVELOPMENT. WETLANDS TO TREAT RUNOFF BEFORE ENTERING THE CREEK. PROVIDE FOR LANDSCAPE & SPORT FIELD IRRIGATION & CREATE UNIQUE HABITAT.
- E3** LONG TERM RE-VEGETATION PLOTS WITH GRASSY LANDSCAPE. OPEN AREAS FOR SECONDARY TRAILS, KITE FLYING, OPEN VIEWS, ETC.
- E4** EXTEND EXISTING PLAINS WOODLAND HABITAT ALONG UPPER SLOPES OF CREEK.
- E5** PLAINS WOODLAND CONSERVATION AREA. SECTIONS TO BE FENCED OFF IN STAGES. TO REHABILITATE EXISTING GREY BOX & UNDERSTORY. AREA FOR FUTURE TRAILS, RECREATIONAL PATH & PICNIC DESTINATIONS.
