1 Introduction

Queensland Capacity Network Pty Ltd (ACN 633 081 517) (QCN Fibre) is committed to providing and maintaining a healthy and safe work environment for QCN Fibre Staff and other persons that may be put at risk from work carried out by QCN Fibre and conducting its business in a way that is electrically safe.

This policy sets out how QCN Fibre will fulfil its commitment to workplace health and safety.

2 Background

QCN Fibre is committed to complying with WHS Legislation.

3 Roles

QCN Fibre's staff all have a role in health and safety.

3.1 The Chief Executive will

The Chief Executive will comply with take reasonable steps to verify QCN Fibre's compliance with WHS Legislation including by:

- Acquiring and keeping up to date knowledge of WHS matters (which includes electrical safety matters and the safe conduct of transport activities).
- Gaining an understanding of the nature of the operations of QCN Fibre (including its transport operations) and generally of the hazards and risks (including public risks from transport activities) associated with those operations.
- Ensuring QCN Fibre has available for use, and uses, appropriate resources and processes to eliminate so far as is reasonably practicable and if it is not reasonably practicable to eliminate risks, to minimise risks to health and safety (including risks to electrical safety) from work carried out by QCN Fibre (including its transport activities).
- Ensure QCN Fibre has appropriate processes for receiving and considering information regarding incidents, hazards and risks and responding in a timely way to that information.
- Ensure QCN Fibre has, and implements, processes for complying with any duty or obligation that QCN Fibre has under the WHS Legislation. This includes QCN Fibre's obligations to:
 - report notifiable incidents;
 - consult with workers;
 - ensure compliance with notices issued under WHS Legislation;
 - ensure the provision of training and instruction to workers about work health and safety (including electrical safety); and
 - ensure that health and safety representatives receive their entitlements to training.
- Verify the provision, use and implementation of resources and processes referred to in second - fifth points above.
- Encouraging a culture of health, safety, open communication, consultation and involvement at all levels across QCN Fibre
- Verifying that all staff demonstrate and uphold behaviour aligned to QCN Fibre's Code of Conduct, and
- Maintaining a Safety Framework as set out in Appendix A.

3.2 QCN Fibre Staff will

All QCN Fibre Staff will:

- Take reasonable care for their own health and safety (including electrical safety) and the safety of others.
- Take reasonable care that their acts or omissions do not adversely affect the health and safety of other persons (including the electrical safety of other persons or property).
- Comply with reasonable instructions given by QCN Fibre to comply with WHS Legislation.
- Cooperate with this Policy, the QCN Fibre Safety Framework, the Work Health and Safety Procedure and any other policies and procedures in place to protect work health and safety at QCN Fibre.
- Immediately report all incidents and accidents in the Workplace in accordance with the incident reporting requirements set out in the Work Health and Safety Procedure.
- Identify and report any hazards in a Workplace
- Use equipment safely and in the correct manner.
- Participate in work health and safety training.
- Participate in work health and safety consultation, and
- Comply with WHS Legislation.

3.3 Reporting Safety Issues

Anyone who sustains an injury or illness or observes a potential hazard or near miss in a Workplace is required to immediately report the incident to the Chief Executive or their delegate. This applies even if the injury or illness does not require medical attention or if no injury or damage has occurred. In addition, QCN Fibre Staff must immediately report any incidents relating to third parties.

3.4 Discrimination

It is unlawful to discriminate against any member of QCN Fibre Staff for a reason that is prohibited under WHS Legislation including because they raise or propose to raise an issue or concern about work health and safety including within QCN Fibre. QCN Fibre Staff recognise and must comply with this important protection.

4 Compliance

Any breach of the obligations contained in this Policy may result in disciplinary action being taken up to and including termination of employment or other engagement by QCN Fibre.

5 General

This Policy summarises some of the rights and obligations which are created by the WHS Legislation. This Policy is not intended to go beyond the requirements of the WHS Legislation. This policy is not a term of any contract, including any contract of employment and does not impose any contractual duties, implied or otherwise, on QCN Fibre. This policy may be varied by QCN Fibre from time to time.

6 Definitions

Term	Definition
Reasonably Practicable	<p>Means that which is, or was at a particular time, able to be done in relation to ensuring health and safety, taking into account and weighing up all relevant matters including:</p> <ul style="list-style-type: none"> • The likelihood of a hazard or risk occurring (i.e. the probability of a person being exposed to harm) • The degree of harm that would result if the hazard or risk occurred (i.e. the potential seriousness of injury or harm) • What the person concerned knows, or ought to reasonably know, about the hazard or risk and ways of eliminating or minimising the risk • The availability of suitable ways to eliminate or minimise the risk, and after assessing the extent of the risk and the available ways of eliminating or minimising the risk, the cost associated with available ways of eliminating or minimising the risk, including whether the cost is grossly disproportionate to the risk
QCN Fibre Staff	<p>Includes any QCN Fibre employee whether permanent, temporary, full-time, part-time or casual, or any volunteer, student gaining work experience, contractor, sub-contractor, employee of a contractor or sub-contractor, consultant, labour hire worker, outworker, apprentice or trainee, or anyone who carries out work in any other capacity for QCN Fibre.</p>
QCN Fibre Safety Framework	<p>Is comprised of a set of documents including a policy and procedure established by QCN Fibre to assist it meet its obligations under WHS Legislation, which may be varied from time to time as further set out in Appendix A of this policy.</p>
WHS Legislation	<p>The health and safety legislation in operation in Queensland that applies to QCN Fibre and includes the:</p> <ul style="list-style-type: none"> • <i>Work Health and Safety Act 2011 (Qld)</i> • <i>Work Health and Safety Regulation 2011 (Qld)</i> • <i>Electrical Safety Act 2002 (Qld)</i> • <i>Electrical Safety Regulation 2013 (Qld)</i> • Heavy Vehicle National Law and associated regulations, and • Any associated Codes of Practice <p>as varied from time to time.</p>
Workplace	<p>A place where work is carried out for QCN Fibre and includes any place where a staff member goes, or is likely to be, while at work.</p>
