Task #	Task description	Details	Task time
1.	By 1800 (previous day)- Assess need for NPO order	Provider writes NPO order and spontaneous breathing trial (SBT)	mins
2.	By midnight- Huddle	R2/R1, Lead RT, Charge Nurse huddle (Potentially extubatable vs. only SBT)	
3.	By 0200- RN: Ensure patient is NPO	Nurse ensures patient is NPO. If there is no NPO order then get one from the provider	mins
4.	By 0230- Charge nurse rounding	Charge nurse rounds with primary RN's to validate patient acuity	mins
5.	By 0300- Charge nurse attends morning huddle	Charge nurse attends hospital morning huddle	mins
6.	By 0430- Wean off sedation	Nurse starts weaning off sedation by titrating to the ordered RASS score	mins
7.	By 0500- RT: Place patient on SBT	Respiratory therapist to follow ventilator weaning protocol/ SBT	mins
8.	By 0530- Complete patient evaluation	Respiratory therapist completes daily evaluation of patient per policy (Check weaning parameters ex. NIF, RSBI)	mins
9.	By 0530- RN/RT: Draw ABG	Nurse to draw ABG 15-30 minutes after the start of SBT and ensure it is sent to the lab immediately	mins
10.	0545- ICU leadership meeting	ICU leadership (overnight resident, fellow, charge nurse, and RT lead) will <b>meet in front of the patient assignment board</b> to determine order of rounds based on acuity and determine who can be extubated	mins

12.	By 0600- Begin SICU rounds	Round on patients based on acuity/list created	mins

14.	RT provides input	RT provides patient input (e.g. ventilator setting, respiratory status, etc.)	mins

18.	By noon: Discontinue ventilator order	Provider to discontinue ventilator order by noon on patients extubated after morning rounds	mins
